


MLFI-25 New Business Volume (Year-Over-Year Comparison)








Aging of Receivables Over 30 Days









Average Losses (Charge-offs) as a % of Net Receivables








Credit Approvals As % of All Decisions Submitted











Percentage of Organizations That Saw a Downturn in Business Year Over Year








