# Full Report on Manufacturers' Shipments, Inventories and Orders March 2014

## **Summary**

New orders for manufactured goods in March, up two consecutive months, increased \$5.3 billion or 1.1 percent to \$493.9 billion, the U.S. Census Bureau reported today. This followed a 1.5 percent February increase. Excluding transportation, new orders increased 0.6 percent.

Shipments, also up two consecutive months, increased \$1.4 billion or 0.3 percent to \$494.9 billion. This was at the highest level since the series was first published on a NAICS basis in 1992 and followed a 0.9 percent February increase.

Unfilled orders, up thirteen of the last fourteen months, increased \$6.9 billion or 0.6 percent to \$1,069.3 billion. This was also at the highest level since the series was first published on a NAICS basis and followed a 0.3 percent February increase. The unfilled orders-to-shipments ratio was 6.44, down from 6.49 in February.

Inventories, up fifteen of the last sixteen months, increased \$0.6 billion or 0.1 percent to \$643.1 billion. This was also at the highest level since the series was first published on a NAICS basis and followed a 0.7 percent February increase. The inventories-to-shipments ratio was 1.30, unchanged from February.

#### **New Orders**

New orders for manufactured durable goods in March, up two consecutive months, increased \$6.7 billion or 2.9 percent to \$236.0 billion, revised from the previously published 2.6 percent increase. This followed a 2.3 percent February increase.

Transportation equipment, also up two consecutive months, led the increase, up \$2.9 billion or 4.0 percent to \$74.2 billion.

New orders for manufactured nondurable goods decreased \$1.4 billion or 0.6 percent to \$257.9 billion.

### **Shipments**

Shipments of manufactured durable goods in March, up two consecutive months, increased \$2.8 billion or 1.2 percent to \$237.1 billion, revised from the previously published 1.1 percent increase. This followed a 1.0 percent February increase.

Transportation equipment, also up two consecutive months, led the increase, up \$1.0 billion or 1.5 percent

to \$70.0 billion.

Shipments of manufactured nondurable goods, down two of the last three months, decreased \$1.4 billion or 0.6 percent to \$257.9 billion. This followed a 0.9 percent February increase. Petroleum and coal products, also down two of the last three months, drove the decrease, down \$2.0 billion or 2.8 percent to \$71.5 billion.

#### **Unfilled Orders**

Unfilled orders for manufactured durable goods in March, up thirteen of the last fourteen months, increased \$6.9 billion or 0.6 percent to \$1,069.3 billion, unchanged from the previously published increase. This was at the highest level since the series was first published on a NAICS basis and followed a 0.3 percent February increase.

Transportation equipment, up six of the last seven months, led the increase, up \$4.2 billion or 0.6 percent to \$663.2 billion.

#### **Inventories**

Inventories of manufactured durable goods in March, up eleven of the last twelve months, increased \$1.2 billion or 0.3 percent to \$393.3 billion, revised from the previously published 0.5 percent increase. This was at the highest level since the series was first published on a NAICS basis and followed a 0.8 percent February increase.

Transportation equipment, up twenty-two of the last twenty-three months, led the increase, up \$0.9 billion or 0.7 percent to \$126.0 billion.

Inventories of manufactured nondurable goods, down following two consecutive monthly increases, decreased \$0.6 billion or 0.2 percent to \$249.7 billion. This followed a 0.6 percent February increase. Petroleum and coal products, down six of the last seven months, drove the decrease, down \$1.1 billion or 2.2 percent to \$47.2 billion.

By stage of fabrication, March materials and supplies increased 0.4 percent in durable goods and decreased 1.2 percent in nondurable goods. Work in process increased 0.2 percent in durable goods and 0.9 percent in nondurable goods. Finished goods increased 0.4 percent in durable goods and decreased 0.1 percent in nondurable goods.

# **Survey Description**

This report is compiled from results of the U.S. Census Bureau's Manufacturers' Shipments, Inventories, and Orders (M3) survey. This survey provides statistics on manufacturers' value of shipments, new orders (net of cancellations), end-of-month order backlog (unfilled orders), end-of-month total inventory (at current cost or market value), and inventories by stage of fabrication (materials and supplies, work-in-process, and finished goods). The M3 includes approximately 4,300 reporting units. Units may be divisions of diversified large companies, large homogenous companies, or single-unit manufacturers in 89 industry categories. Due to the small monthly sample, these 89 categories have been combined into 65 publication levels. The survey methodology assumes that the month-to-month changes of the total operations of those companies in the monthly survey effectively represent the month-to-month movements of all establishments that make up the category. The current coverage levels in the survey show that reported data in the monthly survey represent approximately 60 percent of the shipments estimates at the total manufacturing level. Data published represent manufacturing in a calendar month. The data collection is based on a voluntary survey authorized by Title 13 of the United States Code.

The data presented in this release are based on data obtained from a panel of 4,300 reporting units and provide an indication of the activity within the manufacturing sector. The results differ from what would be obtained from a complete enumeration of all manufacturing companies. In addition, a different panel of 4,300 companies would yield different results. The M3 panel is comprised of companies with \$500 million or more in shipments and a limited number of smaller companies. From a statistical perspective, the panel is not a probability sample; therefore, the sampling errors that are normally provided with sample surveys cannot be measured. Nonsampling errors are attributable to many sources. The use of company or divisional reports to estimate the monthly change for establishments is one source of nonsampling error. The use of primarily large companies to represent the month-to-month movement of all companies is another potential source. Any corrections will be published in the full report. Corrections received after the full report will be released in the next month's advance report. Any revisions made later than two months will be reflected in the annual benchmark publication.

#### **Notice of Revisions Due to Updated Seasonal Adjustment Models**

On May 15, 2014, monthly seasonally adjusted data for Manufacturers' Shipments, Inventories, and Orders, based on the North American Industry Classification System, will be revised for January 1992 through March 2014. There will be no accompanying press release containing revised seasonally adjusted data for January through March of 2014, and historical data not seasonally adjusted will be unchanged. These revisions to the historical seasonally adjusted data will be based on the results of the recent annual review of the seasonal adjustment models. These updated models will also be used to produce seasonally adjusted data from the Manufacturers' Shipments, Inventories, and Orders Survey, beginning with the April 2014 Advance Report on Durable Goods scheduled for release on May 27, 2014 and the full report scheduled for release on June 3, 2014.
